## RESEARCH

My research deals with 3 main topics:

1) With 3 colleagues I analyzed the French citizen perceptions and experiences of the civil and criminal justice system, depending on class, gender, race/ethnicity and political orientation (roles assigned to law, courts & law professions; inequalities before the law and the judicial system; legal decision-making, expert and lay judgment, what is a just and fair sentence?...). From a theoretical perspective, the research is also in line with legal consciousness studies. It opens discussions with scholarship on policy feedback, procedural justice and law & emotion. The results of this mixed method (focus groups, quantitative survey) research were published as a book in Sept. 2022 and I am preparing articles in English.

The research I will conduct in Arizona further explores one dimension, regarding access to justice and inequalities. The aim is to deepen understanding why so many people fail to (or do not) resort to their rights, when they are facing conflicts, because this generates inequalities; and to understand if and how citizens make a link between those conflicts rooted in their daily lives, and the democratic institutions. She will carry out photo-elicitation interviews completed by a quantitative survey, and if possible, observations in courts.

- 2) I studied the reform processes taking place in the judicial systems in France, Belgium and Italy from the 1990s: the mobilizations of law professionals as interest groups to overcome several veto players in the lawmaking processes; relations between justice and politics; the entrenchment of a managerial logic and instruments based on bottom up and national top down initiatives (book published in 2018, another original manuscript of my Habilitation à diriger des recherches in 2019, and peer-review articles such as in Comparative Political Studies). The research was based on interviews with magistrates and clerks, observations of their concrete work from the perspective of political sociology, sociology of professions and public policy analysis. I also published a special issue about judicial politics in Law and Social Inquiry.
- 3) I analyzed parliaments and elected people regarding their conceptions of democracy & representation, their roles & values, their participation to the lawmaking (article published in the *Journal of Legislative Studies*). Much of my research compares citizen's, professionals' or elected people's point of view. It is characterized by an interdisciplinary approach (sociology, political science, law) and based on mixed research design: qualitative (in-depth individual interviews, focus groups, observations) and quantitative (regressions with colleagues; factorial & cluster analysis). Finally, I have always been very much interested in how to do comparative research in the social sciences (I wrote a methodological book in 2005) and how transfer processes of managerial tools or scientific concepts occur: from the private to the public sector, from one country to another...
